

Total Fraud:	Cases down by 18% to 84,000 Value up by 11% to £207 million			
HB/CTB:	Cases fell by more than half to just over 27,000 Value fell by 13% to £109.7 million This decline was expected			
Council tax discount:	Cases dropped by 12% to 48,000 Value dropped by 3% to £18.5 million			
Non-benefit (corporate):	Cases decreased by 8% to 57,000 Value increased by 63% to £97 million			
Tenancy:	Properties recovered decreased by 1% to 2,993 London recovers more properties than the rest of the country combined




Benefit and Non-benefit (corporate) fraud From 2016/17 just call it 'FRAUD'

Counter fraud capacity




Nationally, less than half (45.7%) of councils have a corporate counter fraud team

However:

- London, 93.5% of councils have a corporate fraud team
- Rest of the country, just 37.4% have a corporate fraud team



Local variations in fraud detection




Fraudsters:


