






Supported Accomodation Workshop Haydock Mecure Hotel Wednesday 5th February 2020

With the funding of supported accommodation staying within local authority housing benefit departments, there is uncertainty amongst many decision makers regarding levels of rent, rent setting, eligible service charges and the true costs of supported accommodation.

The workshop will provide an insight into how supported accommodation rents are set, how housing related support works in the field and the savings provided by using and funding supported accommodation. Followed by an insight into the decisions made by a Revenues and Benefit Manager in real life, this will all be bought together into an afternoon workshop. The afternoon workshop will look at a mock housing association and a sample supported accommodation rent and will allow discussion around what decisions you would make if this application landed on your desk.

Aimed at Team Managers or assessors responsible for making decisions on supported accommodation, due to the room size at the venue and to enable the workshop to be effective, the delegate numbers are limited to 30 and on this occasion there won't be capacity for sponsors to attend. If nearer the time, there is space, we will contact sponsors then.
