The day will include a look at how premises are valued, a subject that will be covered by **Geoff Fisher (Pictured) who is**



a Past National President of the IRRV and previously worked as a Valuation Officer in London for 21 years. Beverley McDougall, a Director at Lambert Smith Hampton, will cover appeals from the viewpoint of the private sector whilst Paul McDermott, Director of Inform CPI Limited and a member of IRRV's National Council, will talk about how local authorities can ensure they are maximising the rateable value in the Rating List. Robin Gibbons, Business Rates Manager at Bolton Council, will cover the topic of completion notices and the day will be concluded by Richard Kerr, Director at Greenhalgh Kerr, who will provide an update on recent cases involving charities and rates mitigation.

Taking Control of Goods – the unintended consequences

Wednesday 22nd July 2015 - Venue – Shaw Hill Golf and Country Club, Chorley -
