Phoenix are hosting a 1-year review of the Tribunal Courts & Enforcement Act and its 3 sets of supporting Regulations at Manchester United FC's Old Trafford Stadium on Thursday 23rd April 2015.

The timing of the seminar is ideal coinciding with the proposed review by the Ministry of Justice. Presented by Paul Caddy, the Immediate Past President of The Civil Enforcement Association (CIVEA) and an Authorised High Court Enforcement Officer the reality of the new Regulations will be under discussion and percentage of payments made at each stage of recovery will be reported on. Local Government Practitioners attending will, therefore, learn about National payment trends across different debt types and the impact of the new "compliance" stage of enforcement. Also topics such as Transitional Arrangements, Early "Teething" issue resolution for both local authorities and enforcement firms along with thoughts for the future will be discussed.
