A Landmark IRRV Conference for our Association



The 2012 Annual IRRV Conference held at Telford turned out to be a memorable conference for the Lancashire and Cheshire Association.

President of the Institute Roger Messenger opened the conference with a call to recruit new members, a theme which was re-iterated later by the Chief Executive David Magor. The conference was well attended with the number of delegates increasing on the previous year and a slight increase in the number of exhibitors, despite the financial difficulties that are currently being experienced.

These difficulties were highlighted by a regular at the Annual Conference, Tony Travers of the London School of Economics who pointed out that we were just 18 months into a period of 'austerity' which was expected to last until 2020 or beyond. He explained that Local Government is having to take a larger share of the reductions than Central Government, where a number of departments are protected from the cuts to an extent.

The Chief Executive of the Valuation Tribunal Service, Tony Masella, spoke to the conference on Council Tax Support appeals which the VTS will be responsible for from April 2013. However, he bemoaned the lack of any legislation surrounding the appeals process and likened it to the infamous Donald Rumsfeld speech that referred to 'known unknowns'.

The second day of the conference was dominated by three Parliamentarians – Lord Lytton; Stephen Timms MP the Shadow Employment Minister, and Lord Freud the Minister for Welfare Reform. Stephen Timms informed delegates that the Labour Party was in principal in favour of Universal Credit, although he stressed that there were difficulties with the implementation of the scheme, particularly with IT, timescales and the cost of implementation.

Lord Freud stressed the benefits of Universal Credit and informed delegates that they were needed to ensure that there was a welfare system in place that met the needs of customers alongside an effective support system.

The Performance Awards evening proved to be exceptional for the Lancashire and Cheshire Association with four of the nine gold awards being won by authorities from the region:

- Association of Greater Manchester Authorities for Excellence in Social Inclusion
- Pendle Council in association with Liberata UK for Excellence in Partnership Working
- Stockport Council for Benefits Team of the Year
- Cheshire West and Chester Council for Revenues Team of the Year

There were also silver and bronze awards for Rossendales, Knowsley Council and Avarto with Sefton Council. The evening finale was the handing over of the IRRV Presidency from Roger Messenger to our own Junior Vice President Dave Chapman, who spoke briefly but passionately when he said that achieving the Presidency of the IRRV was the pinnacle of his career.

Overall, the conference was a great success both for the IRRV as a whole as well as for the Lancashire and Cheshire Association, with congratulations and best wishes for the year ahead to Dave.

With all the Government cuts etc would I consider working in the Private Sector?

I'm aware from talking to many colleagues that there are unprecedented numbers having a rethink about their career paths. Some of the reasons are to do with the on going cuts to Local Authority funding, feeling unappreciated, detrimental impact on salaries, pensions and general terms and conditions and changing service delivery models. The introduction of Universal Credit is forcing Benefits staff and Managers to think about what they will do next (although I think this will continue to drag out so another few years left yet).

As someone who worked in Local Government public sector for 27 years and made the decision to move to the Private Sector 4 years ago I feel I can give a balanced view of the differences.

I have been lucky to work for some excellent, forward thinking Councils but have also experienced working for the "behind the times/stuck in their ways Councils".

I felt that I had achieved all I could in my field of Benefits, Revenues and Customer Services in the public sector and wondered what it would like working in the same field but in the private sector.

As someone confident in my ability due to my track record I was still apprehensive as to whether I would cut the mustard in the private sector as I had heard scary stories. These stories just had the effect of making me want to take on the challenge.

The timing was key as I had enjoyed 5 years working for Chester City Council, and as someone who doesn't suffer fools gladly in particular up the line I learnt a lot from some inspirational leaders at Director/Managing Director levels. There was a new unitary council being set up and I was proud of working for Chester City Council right up to the last day of its existence before talking on my new challenge as Head of Customer Centric Services for arvato Public Sector Services leading around 300 staff in the Benefits, Revenues and Customer Services Department for the partnership with Sefton MBC.

My approach to my job role at my level has always been to do what is necessary to achieve my objectives and if this means working 30 hours one week and 60 hours the next then so be it. I am not the type of person who enjoys working in the same place 9 to 5 from, day to day, week to week, year to year – that would be the worst job in the world to me.

Working in the private Sector has given me the chance to work with other private sector companies, set out teaming agreements and joint financial models so that each company is maximising profit from any joint venture.

I've worked on bids to secure more work and am particularly proud of building successful benefits partnership with Derby City Council.

I have a great rapport with Sefton MBC's Client Manager and we both work hard together (and never fall out if we have differences) to improve services to the public in Sefton.

I enjoy working with arvato colleagues, peers across other sites – Chesterfield, East Riding and Slough. We have an excellent support network and appreciate each others unique skills.

My day job is still running a large, busy Department and the focus at the moment like many others is managing the impact of the Welfare Reform Changes.

For those of you thinking about a career move my advice would be if you are good at what you do, are committed and will do what it takes to deliver your objectives then you will be a success in the private sector.

Would I return to the Public Sector? At the moment I would answer that No but as I previously said there are excellent Public Sector organisations out there and I don't believe the private sector is the answer to everything – there is good and bad in both so choosing the right private sector organisation with similar values to your own is key.
